The goal is to improve and promote sustainability and awareness at all levels while complying with the applicable legislation and adopting continual improvement measurements. Continual improvement is measured through our setting goals within the Green Agenda Initiative.

What does our Environmental Policy entail?

Ryder Scott Company recognizes that sustainability means the ability to operate responsibly to meet the needs of the present without compromising the needs of future generations to meet their own needs. Under this Environmental Policy Statement (EPS), our Company defines metrics and goals to measure the impact our Company has on the economy, environment, or society, which can indicate its contribution to Sustainable Development. This allows us to report our environmental, social, and governance (ESG) initiatives and results transparently.

Goals

The goal is to improve and promote sustainability and awareness at all levels by:

- Minimizing pollution and reducing consumption of resources through waste management strategies that promote waste minimization, re-use, recovery and recycling, as appropriate.
- Improving environmental performance by incorporating energy efficiency measures into Ryder Scott's offices and promoting efficient energy use.

Adoption of Policy

Each staff member at Ryder Scott is responsible for upholding the objectives as outlined in this Environmental Policy Statement and our Green Agenda Initiative, which are governed through our Quality and Environmental Assurance Management System (QEAMS).

To ensure compliance and efficient application of the EPS, the CEO will designate the EPS Administrator at the Executive Vice President level who will oversee the implementation and execution of the EPS. The EPS Administrator shall report to the CEO for all EPS changes and approvals. Until reassignment by the CEO, the EPS Administrator is Eric T. Nelson, President and COO.

As required, the overseers for each of the above initiatives and goals, and in particular those with multi- year targets, should prepare a plan and schedule to achieve the objectives.

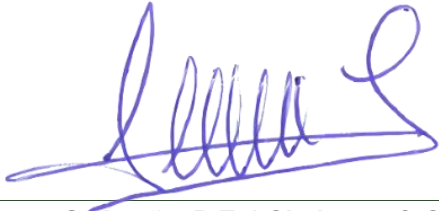

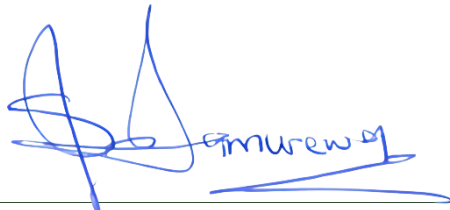
